# Press Coverage for the Peace Memorial Ceremony

Coverage for the Peace Memorial Ceremony (herein “the Ceremony”) on Tuesday, August 6, 2024, must adhere to the following regulations. We thank you for your cooperation.

**Inability to adhere to these regulations may result in the rejection of your press coverage application.** We appreciate your understanding regarding this matter.

Note that **the content of these regulations is subject to change** in response to management and security needs.

## 1. Basic Regulations

### (1) Approved Organizations

In principle, permission to cover the Ceremony is granted to the following organizations only:

#### a) Media Organizations

##### i. Japanese Media

- Member companies of the Japan Newspaper Publishers and Editors Association
- Member companies of the National Association of Commercial Broadcasters in Japan
- Member companies of the Hiroshima City Press Club (herein City Press Club)

##### ii. Foreign Media

1. Member companies of the Foreign Press in Japan (FPIJ)
2. Foreign media organizations that apply via the Foreign Press Center (who do not fall under 1.)

**Note:** In addition to submitting a Press Coverage Application, you must also apply to the Foreign Press Center. Please attach a copy of your Foreign Press Registration Card issued by the Ministry of Foreign Affairs (only applicable to Foreign Press Registration Card holders) or a copy of your ID issued by the media organization you belong to. If you are freelance, attach a copy of a letter from the media organization you have been contracted by.

#### Submit applications to:

Media Relations Division, Foreign Press Center (ma@fpcjpn.or.jp)

#### b) Non-media Organization

- Public institutions
- Cable television broadcasters, local radio stations, filming and production companies

#### c) Others

- Organizations deemed equivalent to the above by the City of Hiroshima’s Public Relations Division.

### (2) Limited Access Area (Map 1)

See Map 1 regarding entry to the Limited Access Area from 5 am. To bypass baggage inspection and other formalities when entering the Limited Access Area (includes re-entry), you must wear a Press Pass issued by the City of Hiroshima and a company armband.

### (3) Press Areas and Press Passes (Map 2)

- a) For security reasons and to ensure the Ceremony proceeds with due dignity, the press is restricted to designated Press Areas. Those covering the Ceremony in these areas **must wear a Press Pass issued by the City of Hiroshima (see right) and a company armband.**
- b) Please make sure to wear the Press Pass around your neck and the armband on your left arm so that they are clearly visible to security personnel.



Also, when filming or photographing following the ceremony, we ask that you wear your company armband so that you can be identified as press.

- c) Press Passes are color-coded according to each Press Area. Before submitting your Press Coverage Application, please carefully confirm which area you would like to apply for. **One pass per person.**

Please see 2. *Press Areas* for information on the areas, Press Pass colors, restrictions, etc.

- A copy of any Foreign Press Registration Cards (if applicable)
- Written Pledge for Press Coverage from Museum Rooftop (Attachment 2)

**Note:** Only applies if applying for a Press Pass for Press Area 7 (Museum Rooftop) (Map 2)

For security purposes, the documents you provide may be shared with the police or other organizations. Thank you for your understanding.

City Press Club members: 5 pm, Monday, July 29, 2024 (Late submissions will not be accepted)

##### **When You May Collect Your Pass**

**From 9 am, July 25 (Thurs) until 12 pm, August 5 (Mon)**

- If you are unable to collect your Press Pass during this time due to unavoidable circumstances, please come to the press reception desk within the Ceremony venue between 6:30 am and 7 am on August 6 (Tues), and we will issue your pass then. **Press Passes will not be issued after 7 am on August 6.**
- See Map 1 regarding entry to the Ceremony venue from 5 am. **Please arrive with plenty of time to spare as crowding is expected.**

<sup>1</sup> Please note the following:

- Entering or exiting Press Areas is not permitted during the specified times. (Outside these times, holders of Press Passes of all colors may enter for preparation purposes.)
- **Strictly no access from the central walkway to the Cenotaph or participant seating after 7:30 am** (excluding Navy Press Pass holders filming/photographing Press Area 10 (Central Walkway)).

<sup>2</sup> **As seating is limited, if we receive more applications than there are seats available, we may ask you to change Press Area.**

<sup>3</sup> Use of stepladders is not permitted. Furthermore, in consideration of Ceremony attendees, please only use the still photography camera stands provided when filming/photographing.

<sup>4</sup> A member of staff will guide members of the press during these portions of the program. **Please follow their instructions.**

<sup>5</sup> Please observe the following:

- Meet at the meeting point described on Map 3 **between 6:40 and 7:20 am (no entry to the museum after 7:20 am)**.  
If you need access to the museum before 6:40 am to set up equipment, please consult with the City of Hiroshima's Public

Relations Division in advance.

- **Bring and wear a helmet as well as fall arrest equipment (full-body safety harness).** Those not wearing helmets or fall arrest equipment will be refused permission to cover the Ceremony.
- **Do not film or photograph anything south of the park from the museum rooftop.**
- Note that when applying for a Press Pass for Press Area 7 (Museum Rooftop), applicants are required to also **submit a Written Pledge for Press coverage from the Peace Memorial Museum Rooftop (Attachment 2).**

<sup>6</sup> Use of stepladders is not permitted.

<sup>7</sup> During Addresses, members of the press will be directed to exit the Limited Access Area via the exit located south of the Central Walkway by staff members.

<sup>8</sup> Communal camera stands will be set up in the northern part of this area. However, please note that the use of stepladders is not permitted on these stands as they disrupt the sound from the loudspeakers.

### 3. Pre-Ceremony Coverage at the Cenotaph and Other Locations

(See Map 1-2 for details)

1. From 6:00 am until the end of the Ceremony, no filming, photography, or coverage is permitted in the Access Permitted Area (except for in designated Press Areas during the Ceremony). Additionally, please do not impede the movement of Cenotaph visitors.
2. Out of consideration for those paying their respects at the Cenotaph, you must not obstruct the view of the front of the Cenotaph at any time when filming.

### 4. Special Regulations for Coverage

1. Out of respect for the participants, we ask that members of the press wear appropriate clothing (for example, white dress shirts and black dress pants). Please note that only white face masks will be allowed. **If covering the Ceremony in Press Areas 3-6 (Triangle Area and Cenotaph Surroundings) and Press Area 10 (Central Walkway) detailed on Map 2, please be particularly mindful of this request.**
2. If you have any inquiries regarding Ceremony coverage, please confer with on-site City staff who are wearing the armband pictured right or are at the press reception desk.
3. Simultaneous interpretation in English via receiver will be available to journalists sitting in Press Area 1 (see Map 2). We ask that you collect your receiver, if necessary, from the press reception desk. **Please return the receiver to the press reception desk promptly following the end of the Ceremony.**
4. Please refrain from covering the Ceremony by air (camera drones included) between 7:40 am and 9:15 am on August 6, as it is disruptive to Ceremony proceedings and out of respect for the citizens of Hiroshima. Additionally, flying drones in Peace Memorial Park is prohibited.

### 5. Traffic Restrictions on the Day of the Ceremony

(See Map 4 for details)

1. No traffic is permitted on Peace Boulevard (from the NHK building to west of Nishi-heiwa-ohashi) from 6:30 to 9:30 am on August 6. However, passage through the area designated by the arrows on Map 4 may be allowed for press organization vehicles that present the designated Traffic Pass. Please note that even vehicles that have presented the Traffic Pass may be denied passage due to security reasons.
  2. No access is permitted to Peace Memorial Park for the duration of the Ceremony; access will only be permitted after 10 am.
  3. A designated Traffic Pass will also be required for vehicular access to Peace Memorial Park from August 1 (Thurs) until the end of August 5 (Mon), as well as outside of traffic restriction times on the day of the Ceremony.
- Note: Excluding broadcast vans and power supply cars, no parking is permitted within Peace Memorial Park.**

## 6. Press Waiting Room

A Press Waiting Room will be set up in Ran 2 (2BF) of the ICCH between 6:30 am and 12 pm on Tuesday, August 6 (see Map 5). Please feel free to use the electrical sockets in the Press Waiting Room and wireless access points for the Internet. You can also use the Wi-Fi in the lobby in front of the Dahlia Room on the same floor.

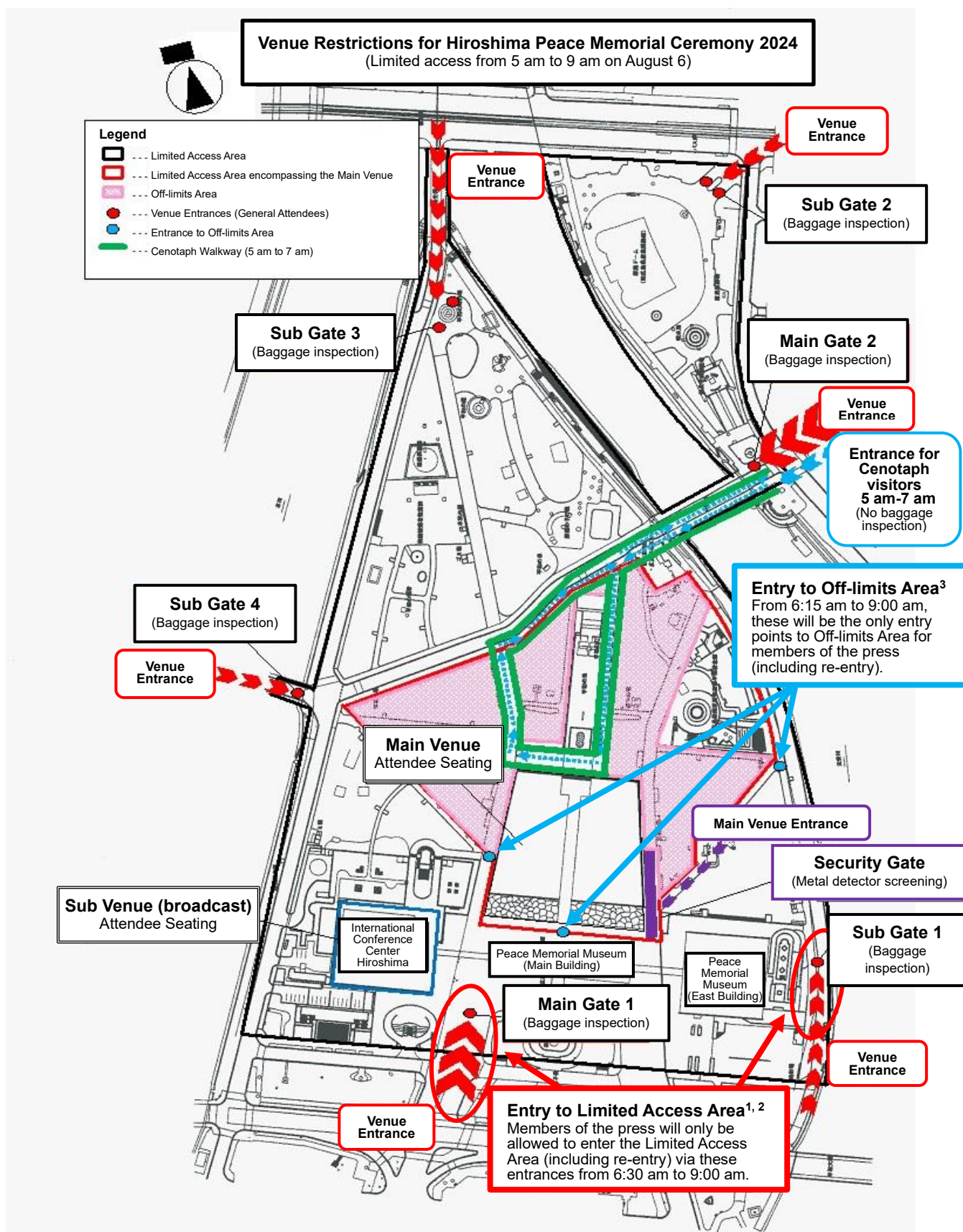

<sup>1</sup>Entry via the Main Gates and Sub Gates between 5:00 am and 6:30 am is permitted.

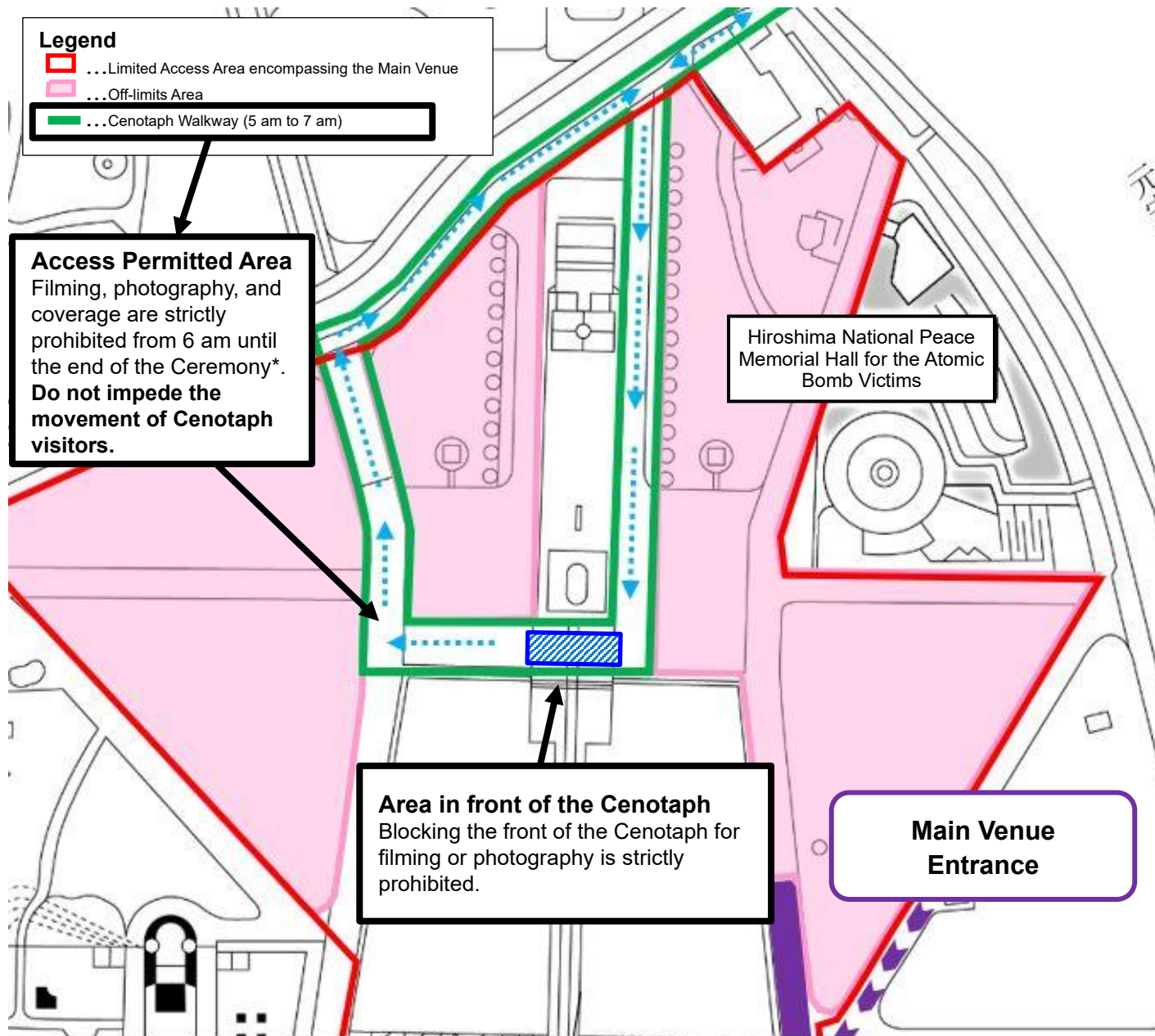
<sup>2</sup>Please use the Guest Entrance at Main Gate 1 or the Priority Entrance at Sub Gate 1.

<sup>4</sup>Venue restrictions are subject to change. Please follow the instructions of our staff on the day.

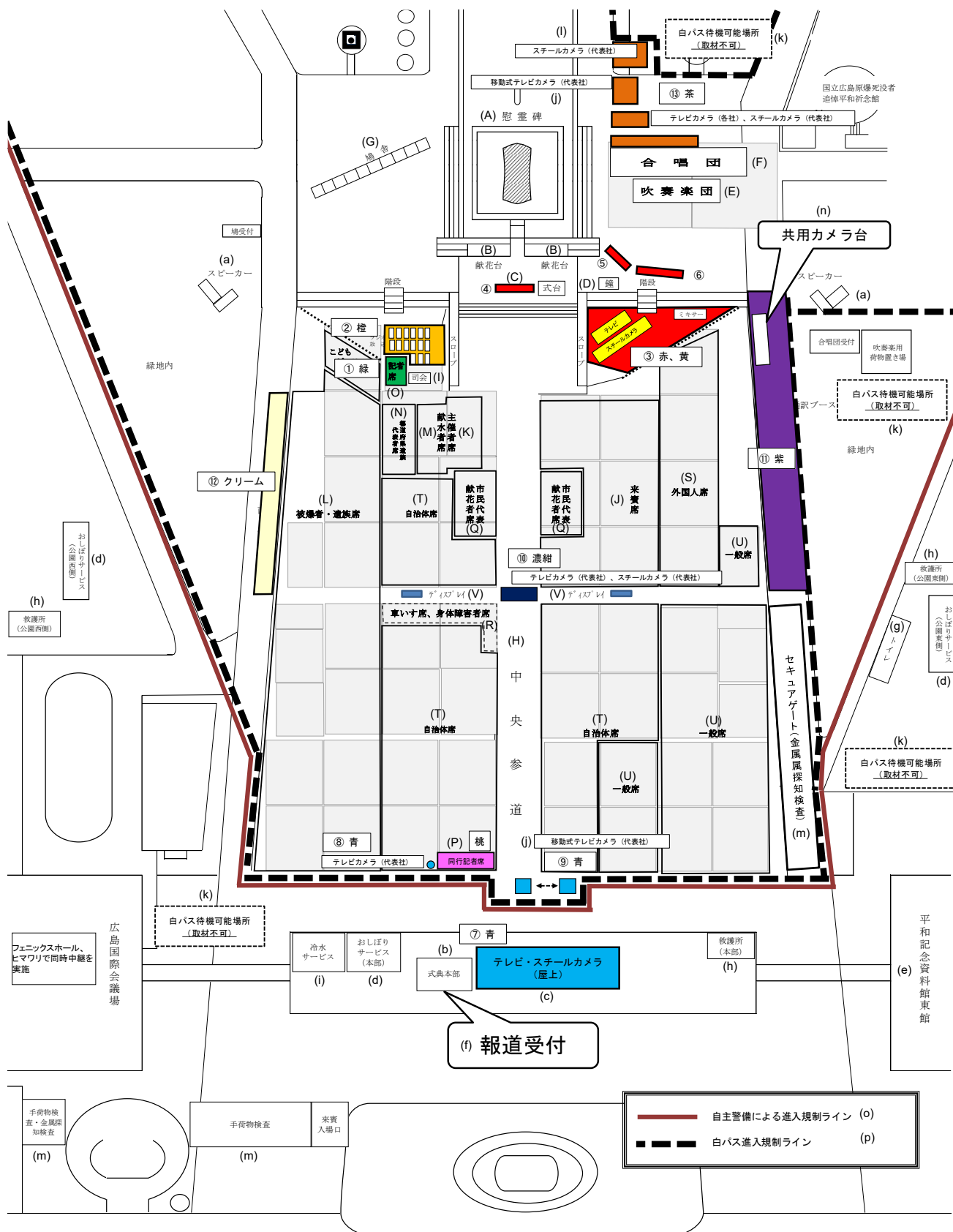
## Ceremony Coverage at the Cenotaph and Other Locations

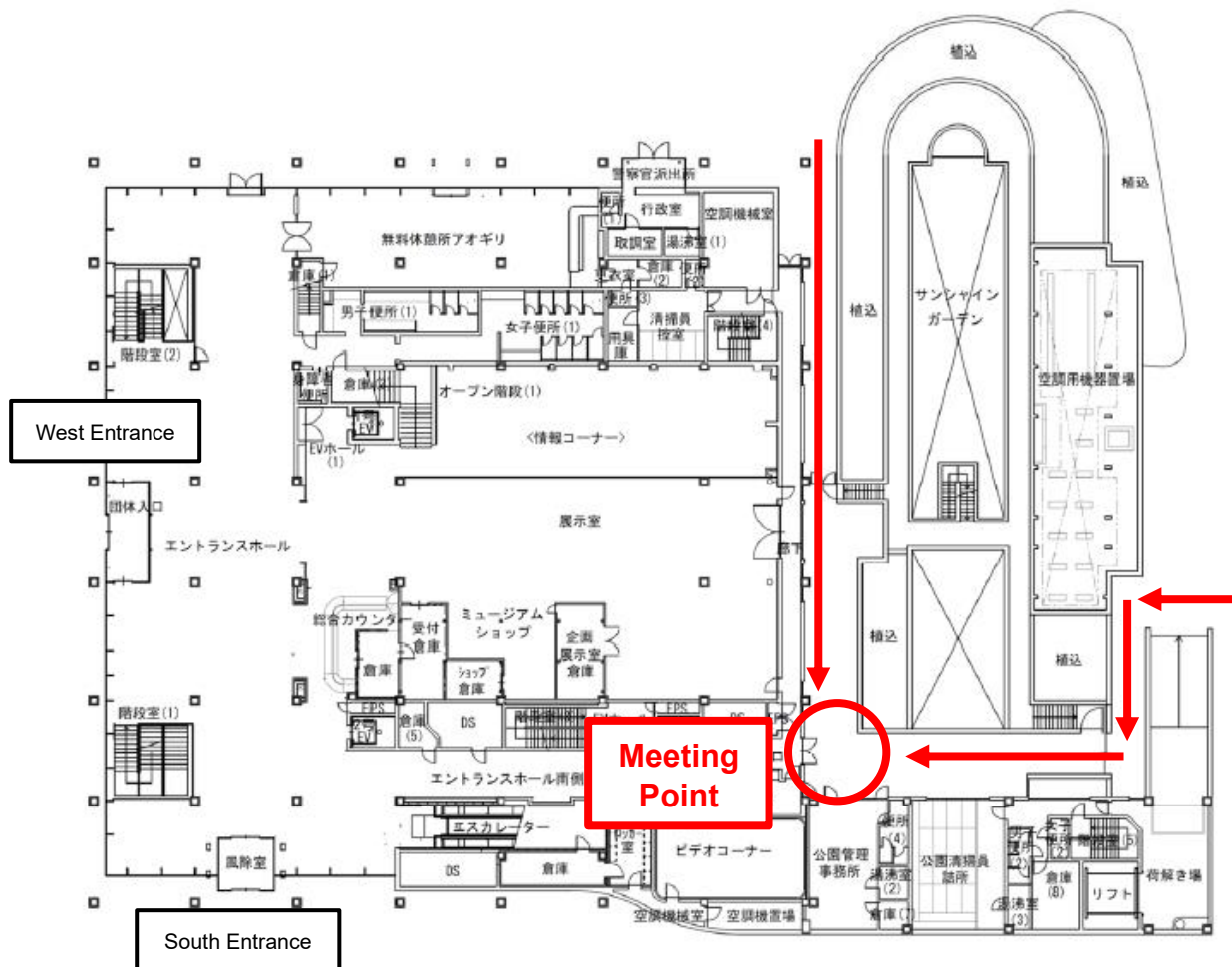

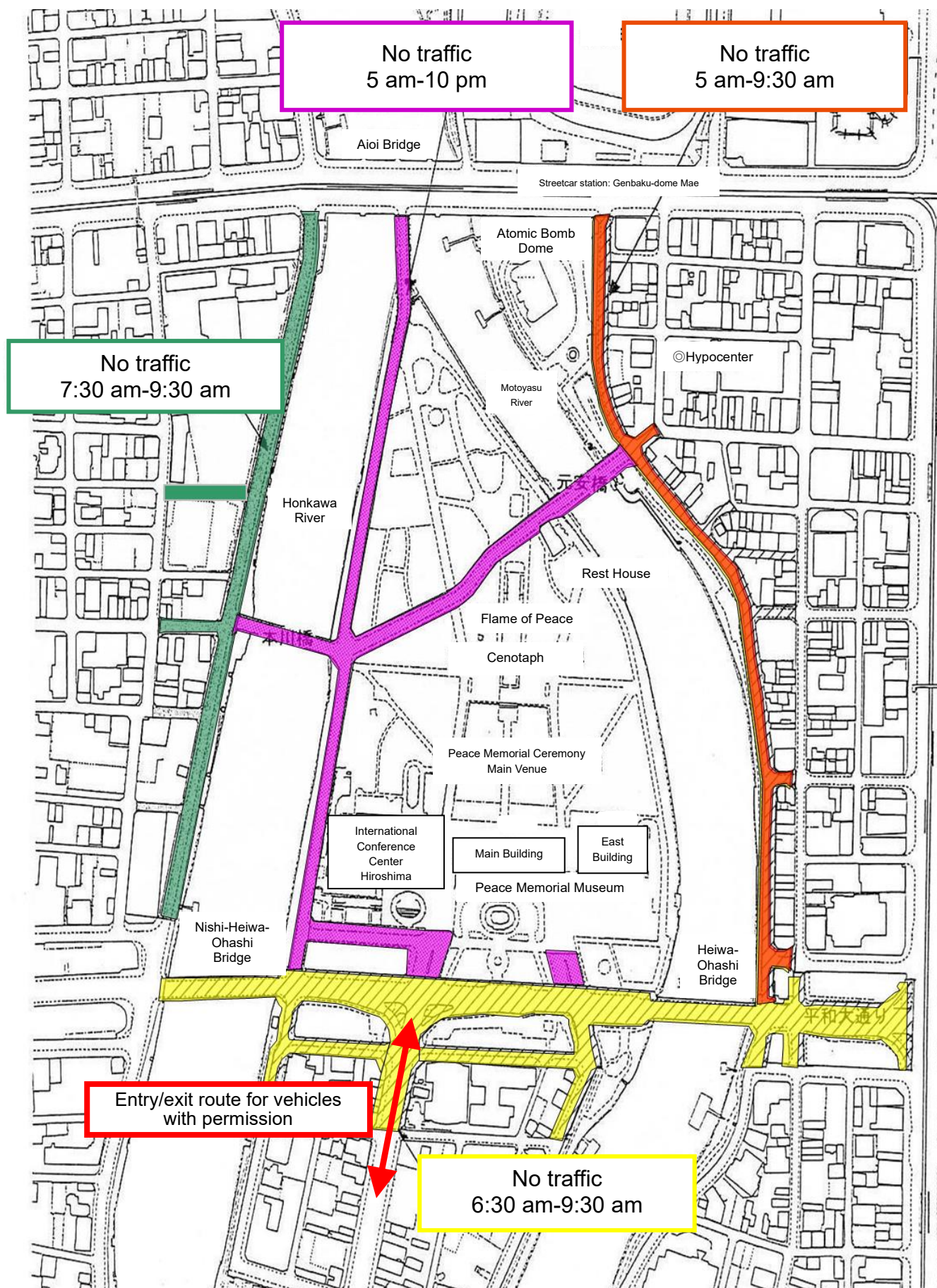

- You will be led from the meeting point to the Peace Memorial Museum rooftop by a staff member.

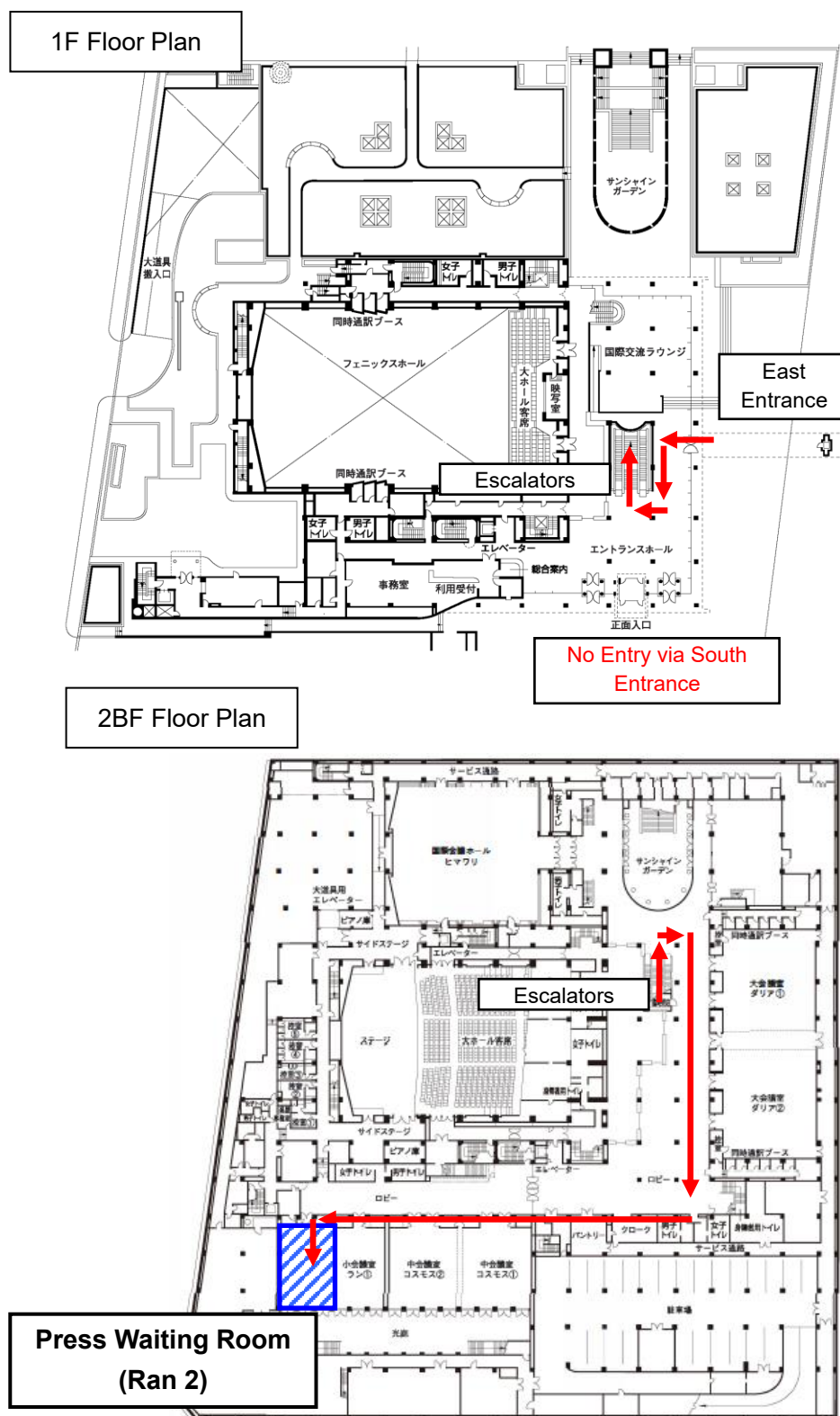
